5. FIREFIGHTING MEASURES

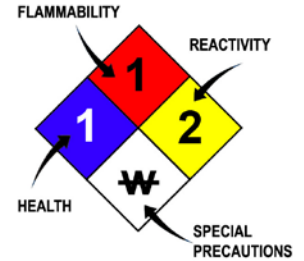
